

Terms & Conditions



In signing the following, you are in agreement to the following terms of your membership with Taeho Martial Arts:

1. Changes to Membership - Requests for changes to a membership can be submitted via our online forms via the Membership Request Forms section in the Member Area on the Taeho Martial Arts website (<https://www.taehomartialarts.com.au/member-area>)
2. Direct Debits - Memberships are based on 4 school terms, 10 weeks of training per term. Taeho Martial Arts offers a direct debit payment option to members which allows members to pay for fees, term by term via a term/monthly instalment/annual basis. Taeho Martial Arts uses Ezidebit® to manage their direct debit processing requirements. Each term is broken down into 3 equal monthly instalment payments billed on the 15th of the month e.g. instalment payments made in Jan/Feb/Mar cover fees for Term 1, Apr/May/Jun cover fees for Term 2 and so on. Failed direct debit payments will incur a fee from Ezidebit.
3. Suspension/Membership Cancellation - Requests for suspension or membership cancellation can be made via our online forms which are located in the Membership Request Forms section in the Member Area on the website. The minimum period a member can suspend is 2 weeks with a maximum of 4 weeks in a calendar year. Suspensions will only take affect during operational periods and are blocked during the Christmas period closure and school holiday period. Medical related suspensions which go over the maximum time, must be accompanied by a doctor's certificate. Members that require longer than 4 weeks will be assessed and advised individually based on circumstances in line with the Taeho Martial Arts Long Term Suspension Policy. Please note that membership suspensions cannot be backdated.
4. Australian Taekwondo Registration - Registration with our Olympic governing body Australian Taekwondo, is compulsory for all members. This payment will be debited on the 1st of February annually. The period of insurance is from 1st February of that year, through to the 1st of February the following year. If a new member joins in Term 1 or Term 2 the full insurance fee is applicable and is included as part of the Taeho Martial Arts 'Start Up Pack'. If a member joins from Term 3 onwards a percentage reduction is applied to the insurance cost and the Start Up Pack fee is reduced. The percentage is determined and advised by Australian Taekwondo. Taeho Martial Arts is bound by this contract and will pass on this reduction to our members. 5. Taeho Martial Arts Waiver - Members will not hold Taeho Martial Arts or its instructors responsible for any injury and agrees to Taeho Martial Arts staff administering first aid in the case of injury as deemed appropriate. Taeho Martial Arts will not be held liable for damage or loss of any members personal items brought into the hall.
6. Price Increases and Membership Terms & Condition changes - One months' notice in writing will be provided prior to any price increase. The new conditions will become effective immediately after the date outlined in any correspondence. 7. Personal Conduct - In order to foster a pleasant and relaxed atmosphere, we ask members to conduct themselves in a responsible, polite and calm manner. Members are asked to be punctual to classes and if any member is late, they will be asked to remain quietly at the hall door until invited into the class by an instructor. Bad language and rude behaviour will not be tolerated under any circumstances.
8. Duty of Care - All children are to be adequately supervised by an appropriate adult before and after class. Taeho Martial Arts instructors and staff members are unable to provide supervision outside of the training hall.
9. Allergy & Asthma Policy – Members that have an allergy are required to have their own EpiPen on hand. Parents will need to stay whilst their child trains so that they can administer it in an emergency. Students that have an asthmatic condition will need to have their own Ventolin available to them should they require it during class.
10. Confidentiality - A member cannot solicit any other student member or staff member in the business of Taekwondo or a business of a similar nature. Members will not disclose or discuss any information pertaining to a student member, staff member or management that is of a personal or confidential nature. Any information that forms part of the Taeho Martial Arts systems, including the student syllabus, programs, drills and games, remains the intellectual property of Taeho Martial Arts and is not to be reproduced, re-engineered, used or discussed outside of your membership. If any of these terms are broken, Taeho Martial Arts will seek an injunction of trade and take legal action for monetary damages.
11. Management Rights - The Management of Taeho Martial Arts reserve the right to cancel the rights of any member (including Life Members) not complying with conditions of membership or codes of conduct, with no reason or refund. This will include publicly criticising the club, morally or criminally.
12. Attire - All members are required to wear a Taeho Martial Arts uniform that is clean and pressed. Fingernails are to be trimmed and clean. Jewellery is not to be worn when training.
13. Photography - Photographs are taken regularly of student activities for members use. These may at times be used for promotional or advertising purposes. Please advise Taeho Martial Arts if you do not want your photos to be published.
